### I. RAAC Report/Survey

-Dara Flinn volunteered to submit the RAAC Educational Needs Survey on behalf of AHA!. She came to the board meeting for approval and additional feedback on the submission. Dara will submit this survey soon.

-She also discussed the Archives on the Hill event. This will be a day for groups such as SAA, NAGARA, and RAAC to lobby for the needs of archives on Capitol Hill. Each participating group was asked to contribute \$500 to pay a part-time coordinator. RAAC had requested its local organizations to provide money for this purpose. The board decided not to contribute.
